ESIC Medical College & Hospital, Bihta, Patna- 801103 is a new establishment under the Ministry of Labour & Employment, Govt. of India. It has started MBBS program since 2021 and is located in the upcoming city of Bihta in the outskirts of Patna, the capital city of Bihar.

With an aim to strengthen its undergraduate program, to start post-graduate program and to augment clinical services, it intends to fill up the following Teaching Faculty Posts and Consultant Super-specialist posts on contractual basis at the earliest. The selected employee will be offered subsidized accommodation facilities in the campus with nominal license fees; there will be an opportunity to obtain teaching and patient care experiences in a structured manner with the help of well-equipped hospital set up having ICU, CT, Scan, NICU, PICU, OT and 24 x7 Laboratory, OT as well as Blood Bank services.
